2. Be an **active/current** member of CACCN **at the time of the award draw** – October 1, 2021.
3. Members may also apply for the **CACCN Certification Bursary**, however, may only be the recipient of either the MIP Award or the CACCN Bursary, not both.
4. Members of the Board of Directors, Affiliate Members and Student Members are ineligible to apply.

Award Submission Process

1. Sign in to complete the application.
2. Online submission at caccn.ca
3. One application per CACCN member.
4. Incomplete submissions and those received after the deadline will not be considered.

Applicant Selection

1. A random blind computerized draw will be conducted on **October 1, 2021**.
2. Recipient will receive an email and voucher certificate with instructions on applying the award to the certification fees in October 2021.

Voucher Expiry

The voucher certificate must be used prior to **November 1, 2021**.
