
The Canadian Critical Care Nursing Conference (CCCNC) is targeted towards healthcare professionals working in or having an interest in critical care/acute care.




Area of Focus





Table reservations cannot be made via the Online processing system.

Table exhibit space does not include electrical services. Electrical services may be purchased if needed.

Table exhibits may be located outside the exhibit hall in the concourse.

Exhibit Payment Terms

Space Assignments

Gold, Silver and Bronze sponsors will receive booth selection. Otherwise, space assignments are first come/first served.

Space Reservation

An exhibit space will be placed on hold upon receipt of your exhibit registration and deposit of 25% (exhibit hall or for table exhibits, in the concourse).

Exhibit Form Submission

Upon submission of the exhibit registration, it is understood that the exhibitor/sponsor, the CCCNC and the CACCN have entered into a binding agreement with respect to the quantity and size of the exhibit space requested, the use thereof and all other matters included in the agreement. Exhibit space contract terms are voided in the event of non-payment and exhibit fees are only refundable under the refund policy. Submission of the exhibit registration forms confirms the exhibitor/sponsor has read and understands the Exhibit Payment forms, Cancellation Policies, and the Terms and Conditions.

Early Bird Rates: deadline May 31, 2024

Should full payment not be received by the deadline date, the exhibit invoice will be adjusted to reflect regular rates.

Regular Rates: deadline September 1, 2024

Should full payment not be received by the deadline date, the exhibit space may be released and/or the exhibitor may not occupy the exhibit space until payment is received.

Liability / Insurance

Exhibitors agree by registering for exhibit space, that the exhibitor assumes entire responsibility and hereby agrees to protect, indemnify and leave the Canadian Association of Critical Care Nurses (CACCN), their volunteers, employees and agents blameless in all claims or fines or legal fees arising out of or caused by the sole negligence of the Delta Regina, its employees or agents.

The exhibitor assumes all responsibility and liability for losses, damages and claims arising out of injury, or damage to the exhibitor's displays, equipment and other property brought on the premises, and shall indemnify and leave blameless the Canadian Association of Critical Care Nurses (CACCN) and the Delta Regina's agents and employees in any and all, such losses, damages, and claims unless losses are the direct result of the CACCN and the Delta Regina's negligence.

The exhibitor acknowledges and agrees that CACCN and the Delta Regina, do not maintain insurance covering the exhibitor's property and that it is the sole responsibility of the exhibitor to obtain and provide confirmation of such coverage.

Proof of Commercial General Liability insurance is required by all exhibitors and must be provided to CCCNC2024 via the online portal by September 1, 2024.

Cancellation Policies

Before July 1, 2024 - 30% administration fee withheld

Before September 1, 2024 - 50% administration fee withheld

After September 1, 2024 - No refund provided



Should you need to cancel, CCCNC2024 will work with the exhibitor to assign the administration fees or full exhibit fees to a remaining sponsorship or will assign to a general educational sponsorship opportunity with inclusion of the exhibitor company name in the conference materials.

Exhibit Installation/Dismantling

Installation

Monday, September 23, 2024, between 0800 hrs and 1600 hrs (to be confirmed).

Installation Deadline

• All exhibit booths must be fully installed by 1700 hrs without exception.

Dismantling:

- Exhibit booths may be dismantled starting at 1430 hrs on Wednesday, September 25, 2024 (to be confirmed).
- Exhibits must be fully dismantled and removed from the venue on Wednesday, September
 25, 2024, unless prior arrangements have been made.

CACCN will not be responsible for transportation, installation, dismantling and/or storage of exhibit goods, displays and/or equipment.

Exhibit Badges



Exhibitors will be responsible for providing **staff badge information** — name, title and email by **September 6, 2024**. Badges will not be printed after September 6 and will only be printed onsite if badging information is incorrect.

To this end, the CACCN will provide space for scientific and/or educational exhibits in accordance with the following Terms and Conditions:

- •Exhibit space may be available to individuals, institutions, Not For Profit Associations, and commercial companies relevant to critical care nursing practice, education, research, or as deemed appropriate by CACCN. CACCN reserves the right to review all applications for exhibits and decline exhibit requests.
- Exhibitors, locations, rates, booth sizing and placement will be determined by CACCN.
- Exhibitors who have made full payment by September 1, 2024, may set up exhibits.
- Each exhibit will be confined to the limit of its respective booth(s) as per the floor plan.
- •The space contracted by an exhibitor is for the sole use by the exhibitor and may not be resold or sublet.
- Exhibitors are expected to set up and dismantle booths within the timeframes allocated. Exhibits may not be packed / dismantled until exhibit closing time.
- Exhibitors must surrender space occupied in the same condition as received. The exhibitor is responsible for any and all damage to the exhibit hall property occurring in or upon the exhibitor's booth space or because of acts of the exhibitor, their employees, agents, licensees or contractors and from and against any-and-all liability, claims and demands which may arise from or be asserted in connection with the foregoing undertaking and responsibilities of the exhibitor.
