# Canadian Critical Care Nursing Conference Policies

# Delegates will be requested to agree with the conference policies prior to completing the registration.

#### **Cancellation Policy – deadline September 5, 2024**

- Refund of conference registration fees/taxes will be issued less a 30% administration fee on the full value of the registration fees paid. Social and special event purchases, if applicable are non-refundable.
- Refunds will be issued if written notice of cancellation is received prior to September 5, 2024 @ 1600 hrs. ET.
- Refund requests should be emailed to <u>caccn@caccn.ca</u>.
- Refunds will not be issued for cancellation after September 5, 2024.
- CCCNC2024 and CACCN will not be responsible for refund requests that do not reach CACCN by the cancellation deadline.
- > Eligible refunds will be issued by cheque by October 31, 2024.
- Refunds for international attendees will be issued via PayPal by October 31, 2024.
- In the event of cancellation of the conference, CCCNC2024 and CACCN will be responsible for the refund of tuition fees only.
